- Final review and approval of 2023 Genesis Conference Budget

- Approved funds for Genesis pastors to attend "Rebuild Conference" in June, hosted by NES
- Discussed progress of the dissolution of the Genesis Conference Foundation in favor of FMF partnership
- Finalized Nominating Committee for 2023
- Assisted churches in shift to Current Income Model
- Dave Frances reported regarding changes in annual reporting. Churches will begin reporting monthly.
