#### **CMCs and Status for serving on conference boards**

**Book of Discipline ¶5320.F:** When a conference ministerial candidate is under appointment to a church as pastor-in-charge, he/she is wondered “clergy” (to maintain a lay/clergy balance) when serving on committees and boards. In all other matters, he/she is considered a “layperson”.

A CMC is still a member of the local church, thus has lay status. This is distinct from ordained Elders who are members of the conference and therefore have the status of clergy.

Book of Discipline ¶5080.A: Each annual conference will have a standing Nominating Committee approved by the annual conference of not less than six members, giving consideration to equal representation of ministerial and lay members.

Genesis Conference BOA approved by motion on 2.16.17 the establishment of a Nominating Committee beginning with the 2017-2018 conference year that will be separate from the BOA and MEG board. The size will be a minimum of 6 and maximum of 8, with terms of three years, and a term limits of two consecutive terms. The Superintendent will be an ex-officio member.
